e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Norway Maple (T1), Norway Maple (T2) - Crown reduction proposal of 30%. Current shape is overhanging both driveway and public footpath blocking out light to residents at 2 Becketts Close on whose property the trees reside. Some smaller branches have already fallen on the driveway and could damage cars kept at the property or be a danger to the owner's children.

New owners of the property note that the trees have not been kept in a good condition with no work carried out for a number of years.

The crown reduction would also enable the clearing of ivy currently damaging the tree making it more susceptible to disease. In this regard the work requested to be carried out would improve the health of the trees in question - the amenity provided by the trees is not in question and there is no desire to damage, fell or impair the long term health of the trees in question.

An arborist has been consulted and instructs that pending relevant permissions the optimum time to undertake these works would be in the Autumn.
