**T1 Horse Chestnut tree** (Roadside) crown lift the canopy to approximately 5m above ground level in line with statutory road clearance, balance all round to formalise.

Crown clean the remaining canopy removing dead wood, diseased and dysfunctional material over 50mm diameter.

Undertake climbing inspection to identify any further issues/structural issues.

**T2 Horse Chestnut tree** (Central lawn) dismantle and remove the tree to ground level or as site conditions allow due to structural issues, canopy dieback and foreseeable failure issues.

**ST1 Stump removal** by stump grinding to approximately 200mm below ground level, remove excess stump arisings.

**LA1** Supply, plant, stake and mulch No1 Semi mature container grown tree 3.6m (species to be confirmed) in line with planning application.
