Holm Oak in front garden of 12 The Rotyngs - Remove dead wood over 20mm diameter, Prune extended growth on south and east side of crown by approx 1-1.5m to create a more uniform shape, prune or remove lowest branches to raise the crown to 5m over the road.

The proposed work is to maintain the tree at a size suitable for it's location.
