Details of the pre-application advice received

It was advised during the meeting that some additional first floor accommodation could probably be achieved through the addition of a first floor rear extension above part of the existing single-storey rear extension (subject, of course, to the design and scale being acceptable.) This would need to run in line with the existing north side wall of the host dwelling and also be stepped in a minimum of 2m from the common boundary with the attached house, to avoid an overbearing impact and harm to outlook for the neighbour. (Light would be unlikely to be significantly affected due to the orientation.)

A front dormer would require planning permission. I understand that this would only need to be fairly small as it would only be required to give headroom to the new staircase to the second floor. However, I am mindful that there is only a small area of sloping roof beside the front facing gable and consequently even a dormer that is kept to the bare minimum dimensions necessary, may be considered to look too cramped. On the other hand, though, that may not be the case.
