I have prepared an annotated birds eye view site map with marked locations of the trees in question , however I have not been able to see where to attach this to the application therefore please request if needed.

## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1. Two ash trees located in the pub car park next to the property, height 19 meters, lateral 14 meters. We recommend a 10 meter pollard reducing the overall height to 9 meters.

T2. one yew tree, height 9.5 meters, lateral 8 meters. We recommend 2-2.5 meter reduction, reducing the overall height to 6.5 - 7 meters.

T3. one honey locust tree, height 14 meters, lateral 5 meters. We recommend a 8 meter pollard reducing the overall height to 5 meters.

T4. a row of four Leyland Cypress trees, height of 12 meters, We recommend a 7 meter reduction reducing the overall height to 5 meters.

T5. One sycamore tree, height 12 meters, lateral 4 meters. We recommend a 7 meter reduction reducing the overall height to 5 meters.

T6. One bay tree, height 10 meters, lateral 3 meters. We recommend a 5 meter reduction reducing the overall height to 5 meters.

T7. Two goat willow trees, height 13 meters, lateral 4 meters. We recommend a 7 meter pollard reducing the overall height to 6 meters.

T8. One fig tree. Height 6.5 meters, lateral 4 meters . We recommend a 3 meter reduction Reducing the overall height to 3.5 meters.

T9. One beech tree. Height 14 meters, lateral 7 meters. We recommend a 2 meter reduction of lateral branches to a height of 5 meters.

T10. One beech tree height 16 meters, lateral 9 meters. We recommend a 4 meter reduction in height and a 2 meter reduction in lateral branches. Reducing the overall height to 12 meters.

T11. One ash tree. Height 18 meters. We recommend a 9 meter pollard reducing the overall height to 9 meters.

T12. One yew tree. Height 6.5 meters, lateral 6.5 meters. We recommend a 3 meter reduction in both height and lateral branches.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
