 2. STRIKING CHARTED AND UNCHARTED BURIED AND OVERHEAD SERVICES INCLUDING BURIED HV & OVERHEAD EHV, GAS ETC.
 3. DEEP DRAINAGE EXCAVATIONS. RISK OF FALLS, COLLAPSE OF TRENCH OR BATTER, CONFINED SPACES.
 4. CONFLICT BETWEEN CONSTRUCTION WORKERS, VISITORS AND GENERAL PUBLIC WITH MOVING PLANT AND VEHICLES.

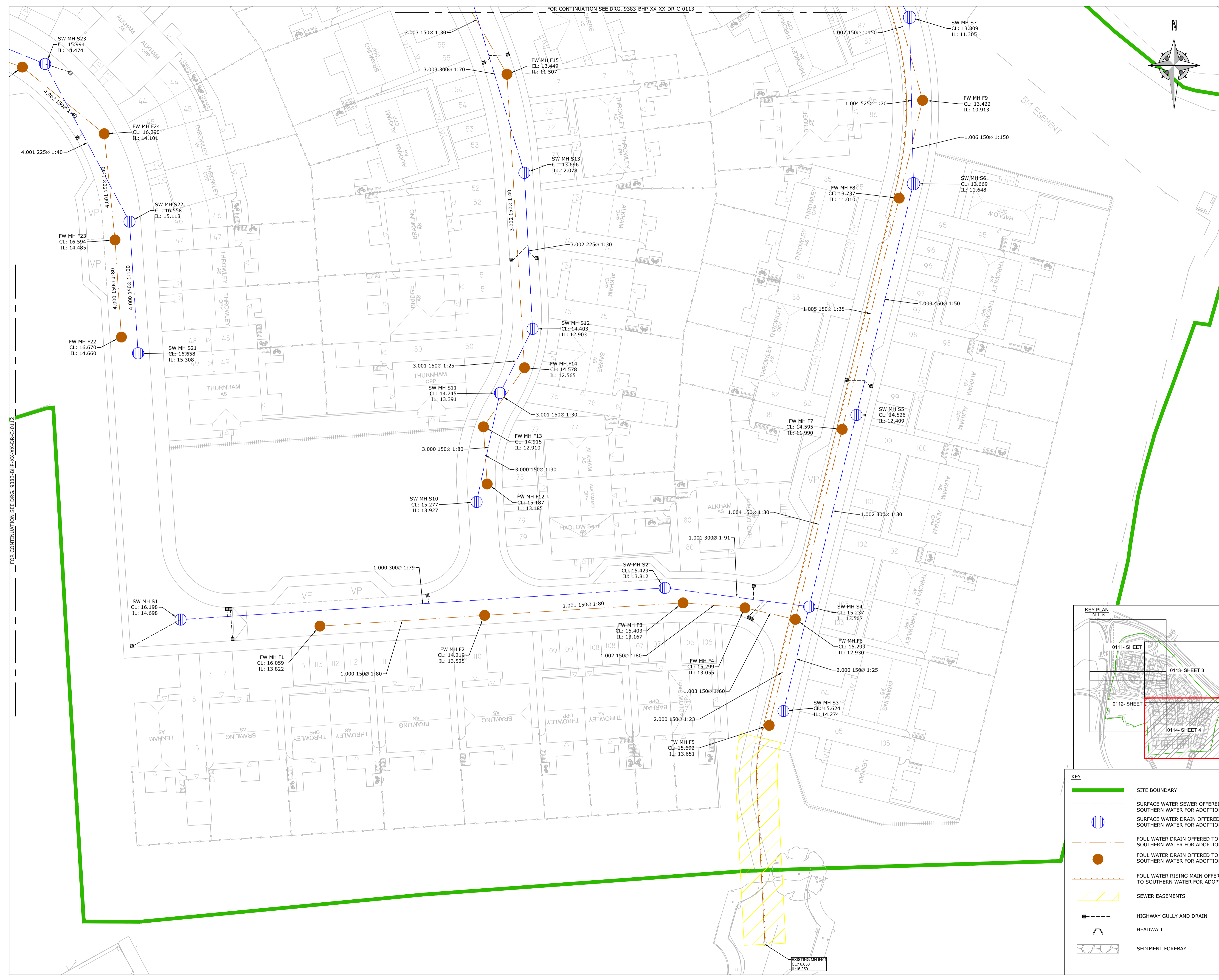
