Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

G1- 3no. Magnolia. Line of three mature magnolias reduced heavily in the past to be reduced back to as close as previous points to allow more light into the pool area whilst discouraging stressed water shoots. Approximate height from 4.5m to 2.5m and width reduced from 3m to 1.5m on all sides.

T2 - Tulip. Mature tree with a few branches un-balancing the crown. Specification to re balance the crown by reducing back 4 branches by approximately 2-3m. Two branches from the top, reducing back into the crown and two on the west side growing towards house, reduced back into crown.

T3 - Yew tree. Large 15m Yew tree covered in dead ivy. Tree reduced heavily on one side in past with no signs of regrowth. Proposal to reduce tree from 15m to 8m, the highest point of growth in order to promote growth lower down.

G4 - Magnolia and Box Elder. Dead Magnolia and dying Box Elder to be removed and replaced.

G5 - 5no. Yew trees. Mature Yew trees showing signs of stress in the forms snapped out limbs and co-dominant stems showing recent movement. Proposal to reduce height by 4-5m from 13m to 8m. Reduce width by approximately 3.5m from 6m to 2.5m. Objective to reduce overall canopy size considerably to reduce lateral weighted stress on the trees and form new denser canopy that can be kept small.

T6 - Cherry - Dying cherry to be removed and replaced.

T7 - Goat Willow - To be removed and replaced as it has out grown it location.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
