Details of the pre-application advice received

In terms of assessing the likelihood of the proposed gate gaining officer support, the main consideration would be the impact that the proposed development would have on the character and appearance of the surrounding area. Overall, I consider that the prevailing characteristics of the streetscene in the immediate vicinity of the site to be low level boundary treatment and open frontages. In the case of the property known as 'Buzby' I accept that there is existing hedging which encloses the frontage of the site. It is likely to be the case that to be acceptable from a highway safety and convenience perspective that the gate will be required to be set back 5m into the site from the edge of the highway. This will be so vehicles do not have to wait on the highway whilst the gate opens. As a result of this I am of the view that taking into account the details submitted, and the character of the area, that if the gate was set back by 5m from the edge of the highway that this would also reduce any impact on the character of the area to an acceptable level. I appreciate that this may have an impact on the available parking space at the property and therefore should an application be submitted, it would also be a requirement that a sufficient level of onsite parking spaces can be accommodated. - I have checked and there will be sufficient space to park 2 cars.
