T001	"Sycamore (Acer pseudoplatanus)"	Remove branch at 5m East crossing with neighbouring tree.
T004	"Sycamore (Acer pseudoplatanus)"	Fell tree and allow to regenerate. Wound at 3m E from branch loss
T010	"Elm (Ulmus sp.)"	Fell tree.
T013	"Common hawthorn (Crataegus monogyna)"	Clear fallen tree.
T014	"Goat willow (Salix caprea)"	Fell tree and allow to regenerate. Broken limb at 5m over road
T015	"Goat willow (Salix caprea)"	Remove 4 limbs overhanging road. Major union failure to N, N stem failed and laying in ditch.
T026	"Common ash (Fraxinus excelsior)"	Fell tree and allow to regenerate. Hollow at 8m (woodpecker hole) inonotus at 7m.
T027	"Common ash (Fraxinus excelsior)"	Fell E stem with inonotus colonisation. Inonotus at 9m
T033	"Horse chestnut (Aesculus hippocastanum)"	Remove major deadwood.
T040	"Sycamore x1 (Acer pseudoplatanus) Elm x3 (Ulmus sp.)"	Fell dead trees (4)
T041	"Sycamore (Acer pseudoplatanus)"	Historic monolith still in range of road. Fell tree. Dead
T042	"Elm (Ulmus sp.)"	Fell tree. Buttresses: Obscured, growing from brickwork. Trunk: Obscured Main unions: Obscured Primary ascending stems: Obscured Branches: Major deadwood
T048	"Sweet chestnut (Castanea sativa)"	Reduce tree to 8m snag (monolith) Top 30% dead.
T050	"Sweet chestnut (Castanea sativa)"	Remove Major deadwood - greater than 25 mm.
T051	"Sweet chestnut (Castanea sativa)"	Reduce tree to 8m snag (monolith). Primary ascending stems: Dead
T057	"Common holly (Ilex aquifolium)"	Remove W stem propped in neighbouring tree marked with red spot. Primary ascending stems: Stem failed at base pointing W
T062	"Sycamore (Acer pseudoplatanus)"	Fell tree and allow it to regenerate. Trunk: Rubbing on Chestnut at 8m
T067	"Sweet chestnut (Castanea sativa)"	Remove major deadwood - greater than 25 mm, and hanging branches overhanging Loddington Lane.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
