Details of the pre-application advice received

Pre-app enquired as to whether the property still had its permitted development rights.

Ben stated that:

Planning permission was granted in 2005 to change the use of the site from C3 (Dwelling-houses) to C2 (Residential Institutions), known as Lee House. Consequently an application is required for any extensions. There is no change of use back to a dwelling on the planning history so this appears to be a

breach of planning control which should be regularised by the applicant before proceeding with any extensions. If it can be proven that the property has been a dwelling for the last ten years a certificate of existing lawful use could be applied for with evidence.
